Ini untuk memaklumkan bahawa Unit Pengurusan Ladang di bawah Syarikat Induk FGV Holdings Berhad dengan nombor keahlian RSPO 1-0225-16-000-00 telah melantik Intertek Certification International Sdn Bhd untuk menjalankan ~~Audit Pengesanan / Audit Pengesanan Semula~~ / **Audit Pengawasan Tahunan (ASA-02)** ke atas **Kilang Sawit Triang** dan pangkalan bekalan /estet yang terletak di **Pahang, Malaysia**. Pengauditan akan dilakukan dari **14 -1 8 April 2025** dengan syarat:

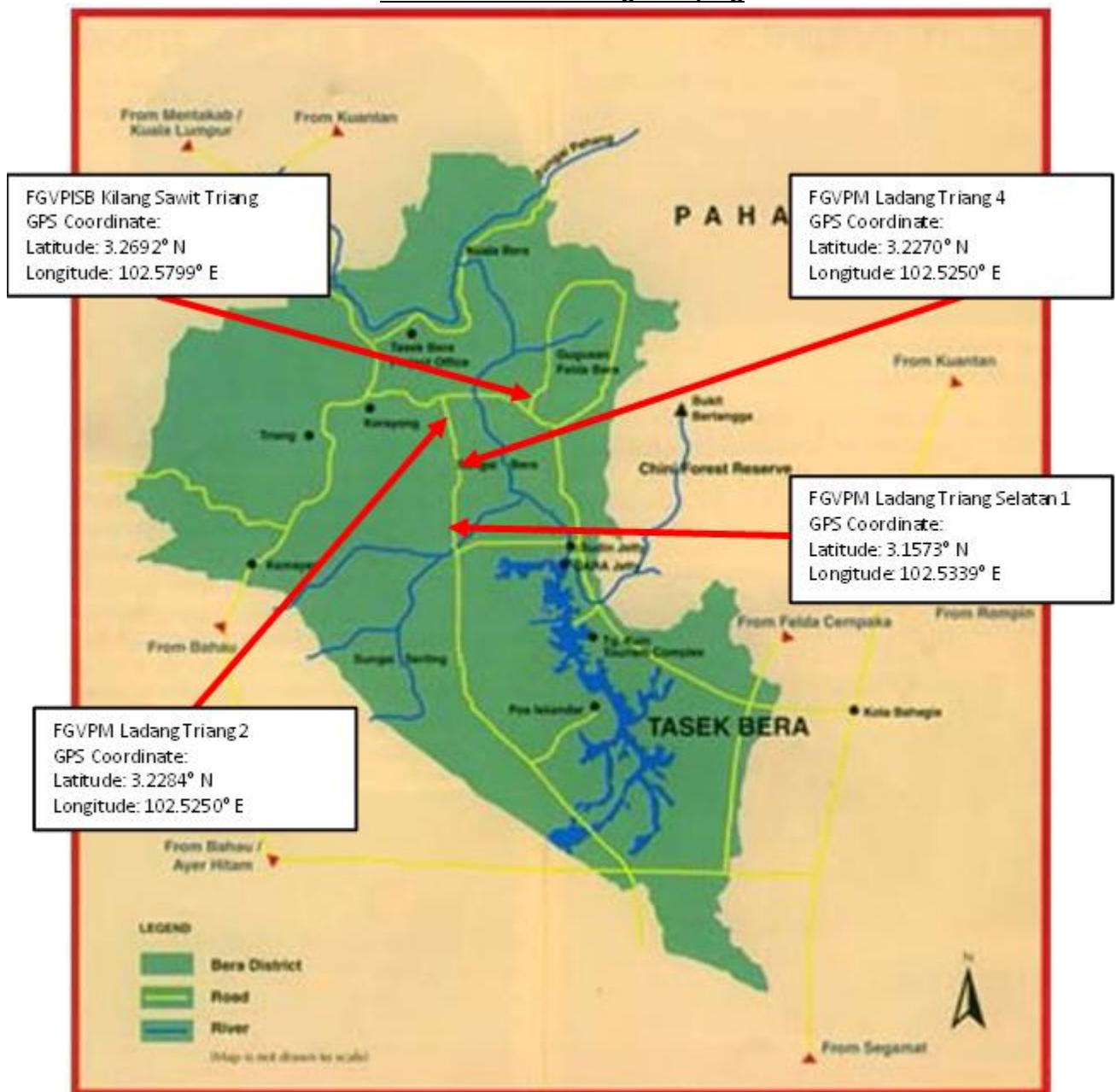
