40.3.2		<ul> <li>a) Disconnect power to the hazardous part immediately after the door, gate, or guard is opened;</li> <li>b) Comply with the interlock switch requirements in Section 39;</li> <li>c) Withstand 100,000 cycles of operation controlling a load not less than that controlled in the product and shall function normally upon completion of the test; and</li> <li>d) Comply with the test specified in Section 65, Interlock System Endurance Test – Recessed Ultrasonic Cleaners and Commercial Trash Compactors and Bailers.</li> </ul>

		<ul> <li>a) There shall not be any electrical or mechanical malfunction of the interlock system, or undue pitting or burning of the switch contacts; and</li> <li>b) The fuse in the grounding connection shall not open.</li> </ul>
